### 4. First-aid Measures

**Description of first-aid measures.****General advice.**

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice.

## 5. Fire-fighting Measures

**Extinguishing media.****Suitable extinguishing media.**

Use: Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

**Special hazards arising from the substance or mixture.**

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. ## 6. Accidental Release Measures

Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Wear protective gloves/clothing and eye/face protection. Stop all work that requires a naked flame, stop all vehicles, stop all machines and equipment that may cause sparks or flames. Do not breathe vapors or spray mist.
